**RULES:**

1. The permit is for the 2010 **Days of '47 Youth Parade and its route ONLY**. The permit is not valid for the Horse Parade, the July 24<sup>th</sup> Parade or any other event or in any other location.
2. If you are selling from a walking cart, each cart must have a separate license.
3. **The permit provided by The Days of '47, Inc. upon acceptance of this Application and payment of the appropriate fee, must be posted and visible on each concession.**
4. Once the parade has started at 10:00 a.m., all vendors must move behind the crowds, leaving the parade route clear – regardless of whether the parade has reached that location.
5. Horns may not be sold due to the danger of spooking horses. You may be required to relocate to accommodate Days of '47 announcers.
6. If you plan to sell food items, contact the Salt Lake County Health Department at 801-313-6620, 788 East Woodoak Lane, Murray, UT 84107, to obtain the required temporary Food Establishment permit.
7. The parade route starts at the corner of 600 East and 500 South in Salt Lake City and runs west to Washington Square. **The permit is for the parade route only and does not allow you to sell items inside Washington Square.**
8. Fees must be submitted by check made payable to **The Days of '47, Inc.** and should be mailed with the completed Application to P.O. Box 112287, Salt Lake City, UT 84147-2287 by **July 1, 2010**. Permits and badges will be returned by mail early in July 2010. You may make arrangements to apply for a permit in person by calling Kathi Izatt at 801-257-7959.
9. Any violation of the rules above or the terms of the permit issued pursuant to this Application will be deemed a forfeiture of the 2010 permit AND no vendor permit will be issued to the Vendor or Group in 2011.

I hereby agree that the persons selling from this permit will comply with all of the rules outlined above and the terms of the permit issued. If such persons fail to comply, in addition to the forfeiture of the permit and non-issuance of a 2011 permit, they will be removed from the parade route and concession items may be confiscated.
